- Entrants must be graduating in the 2020/2021 year from Marysville High School, Early College High School, or Ohio Hi-Point and maintain a grade point average of at least 3.0.

Submission Details:

- All parts of the application must be completed.
- Each essay question must be answered with at least 200 words, and no more than 500.

Dave Amerine is the President of the Marysville Business Association. Entries received after the deadline will not be considered.

- The Marysville Business Association has the right to disqualify any applicant(s) who do not follow the scholarship application guidelines and eligibility.

Award details:

- Three applicants will be selected to receive a \$500 scholarship. The funds will be granted to the scholarship winner in a check made payable to the winner and to the school of your choice.

Judging Details:

- Successfully completed applications received by the deadline will be reviewed by the Marysville Business Association Selection Committee based on how well they have responded to the application and completed the essay questions. In the case of a tie, applicants may be interviewed by the Selection Committee as a tie breaker. The winner will be notified by phone no later than May 3rd and will be asked to attend the Marysville Business Association meeting on May 19th to receive the award.
